## MISS RODEO MINNESOTA FINANCIAL CONTRACT

---

*The Miss Rodeo Minnesota Association (MRMNA) is a 501(c)(3) nonprofit organization and relies on donations and various fundraisers to support its efforts. Funding obtained through these methods allow the Association to remain in good standing with Miss Rodeo America, Inc. as well as provide support to the elected queens.*

*Sponsors solicited by the current title holder of Miss Rodeo Minnesota (MRMN) for her personal benefit during her reign are considered “personal sponsors” and must be approved by the Miss Rodeo Minnesota Association. Personal sponsorships will be treated differently than Association sponsors and will be handled accordingly. Miss Rodeo Minnesota shall not make any agreements, guarantees, or promises for advertising in any official Miss Rodeo Minnesota/Miss Rodeo America publications or any other publications.*

*The titleholder of Miss Rodeo Minnesota is required to raise a minimum of \$5,000 during her reign, of which 30% will be kept by the MRMNA. Funding withheld by the MRMNA is used to complete requirements held by Miss Rodeo America, Inc., such as: national dues and liability insurance, and for various operating expenses. The remaining 70% is to be distributed to MRMN for her travels, wardrobe, and other needs relating to her title of MRMN. Any money raised beyond the minimum requirement will be subject to the MRMNA withholding 10% of the funds and the remaining 90% will be for MRMN’s relevant expenses pertaining to her reign. All funding collected by Miss Rodeo Minnesota must be made payable to the Miss Rodeo Minnesota Association (MRMN Association). MRMN will be required to submit receipts and potentially other documentation to the MRMN Association for reimbursement of her needs.*

*MRMN is required to conduct several events in partnership with the MRMN Association to help complete the minimum financial requirement. These events include: coronation, Miss Rodeo America send off and/or trunk show, and may also include other events as directed by the MRMN Association. Additional fundraising efforts may be conducted with permission of the MRMN Association. Such ventures may include: silent auctions, 50/50 raffles, etc.*

*In regards to product donations as a portion of MRMN’s requirement – product donations do not provide useable dollars for the Association to complete its obligations and therefore cannot be*

used to complete MRMN's financial requirements. However, MRMN should attempt to secure product sponsors of many kinds to help complete her reign. Such product sponsorships may include: chaps, clothing, hair products, etc.
