All applications are subject to approval by the MRMNA and the application deadline to be received is July 5, 2022. The Miss Rodeo Minnesota Association reserves the right to refuse any contestant application. If a contestant is refused entry in the contest, there will be no appeal process. Be sure to utilize the checklist included in the application to ensure you have completed all required paperwork.

When you return your application be sure to include the following (address below):

• **Signed and notarized pageant application agreement**

- Entry fee of \$350 (**cashier's check or money order** payable to the Miss Rodeo Minnesota Association).
- Electronic copy of your biography (not to exceed 150 words) (This must be in WORD format. Email below).
- Copy of your birth certificate, driver's license, and proof of health insurance coverage.
- Photo of yourself in western attire (can be traditional or fashion-forward), does not have to be from a professional photo but does need to be tastefully done.

Tentative clothing requirements will be: one (1) professional outfit for speeches; one (1) professional outfit for personal interviews; one (1) fashion-forward western dress outfits; two (2) rodeo attire outfits and one (1) horsemanship outfit (white button down long sleeve western shirt and blue Wranglers required).

You will be sent an Official Contestant Packet once your application is received. Should you have any questions, please do not hesitate to contact us. We are looking forward to an exciting, fun-filled pageant this year and hope you will be part of it!
