- 1. Signed and notarized pageant application agreement
- 2. Entry fee of \$150 (cashiers check or money order payable to the Miss Rodeo Minnesota Association).
- 3. Electronic copy of your biography (not to exceed 150 words) (This must be in WORD format. Email below).
- 4. Copy of your birth certificate and proof of health insurance coverage.
- 5. Photo of yourself in western attire (can be traditional or fashion-forward), does not have to be from a professional photo but does need to be tastefully done and be a headshot.

Tentative clothing requirements will be: one (1) professional outfit for speeches; one (1) professional outfit for personal interviews; one (1) fashion-forward western dress outfit; two (2) rodeo attire outfits and one (1) horsemanship outfit (white button down western shirt and blue Wranglers required).
