



JUNIOR MISS RODEO MINNESOTA CONTRACT

This agreement is between _____ who has been selected as JrMRMN 2023 and the Miss Rodeo Minnesota Association effective the date set forth herein.

The purpose of this agreement is to state the obligations of "Jr Miss Rodeo Minnesota" and to define the rules that govern her conduct, responsibilities, and attitude while she holds the state title and crown of "Miss Jr Rodeo Minnesota."

General guidelines and rules:

I, THE UNDERSIGNED, having entered and participated in the Junior Miss Rodeo Minnesota Pageant with the understanding and knowledge of the terms and conditions of this Contract and understanding that if designated "Junior Miss Rodeo Minnesota", I would be required to enter this Contract as a condition of being so designated, make the following statements and representations to and agreements with the Junior Miss Rodeo Minnesota Pageant and The Minnesota Rodeo Minnesota Association.

1. I am a female citizen of the United States of America and reside in _____, County of _____, State of Minnesota.
2. I am between the ages of 11 and not older than 15 as of January 1, 2023.
3. I am of good moral character and have never been convicted of any crime.
4. I have never been married, had a marriage annulled, have not had a child, nor am I now pregnant.
5. I have not heretofore authorized any person, firm or corporation to use my name, photograph, picture, present or future title in connection with any endorsement or advertisement or any commercial product or service; and I am not under any contractor other obligation to any person, firm or corporation or have any legal obligation which would prevent my participation in an appearance as Junior Miss Rodeo Minnesota, or

which would prevent or hinder my compliance with the terms, conditions and obligations hereafter specified.

NOW, THEREFORE, IN AND FOR THE CONSIDERATION of my being designated “Junior Miss Rodeo Minnesota” and for other good and valuable consideration, I hereby agree as follows:

1. During my term as “Junior Miss Rodeo Minnesota”, the length of which term shall be from January 1, 2023 through December 31, 2023, I shall not become a contestant or participate in any other beauty or talent pageant or contest or make or agree to any public appearance of any kind without the express permission of The Miss Rodeo Minnesota Association, which permissions shall not be granted in any case where my participation in such event would be in violation of the rules and regulations of the Junior Miss Rodeo Minnesota title.
2. I warrant that all of the above statements and representation made by me are true. In addition, I agree that during my term as “Junior Miss Rodeo Minnesota” I shall conduct myself in a manner which shall uphold and maintain the dignity and the honor of that title and position. I further agree that during my term as “Junior Miss Rodeo Minnesota” I shall not become engaged, married or pregnant.
3. I hereby designate and appoint The Miss Rodeo Minnesota Association as my sole and exclusive representative and agent for making press releases, statements to the news media, contracts, engagements and appearances during my term as “Junior Miss Rodeo Minnesota”. I agree to make myself available for such appearances, interviews, filming, tapings, photographic and recording sessions and such other events as are determined by The Minnesota Rodeo Minnesota Association, provided that such shall not unreasonably interfere with my educational and/or employment pursuits.
4. It is expressly understood and agreed that in the event I do not comply with the terms and conditions of this Contract, that The Miss Rodeo Minnesota Association has the absolute right to request that I resign the title and office of “Junior Miss Rodeo Minnesota” in which event I shall immediately resign as and forfeit the right to said title and office. In addition, upon my resignation, I shall forfeit and/or return to The Miss Rodeo Minnesota Association all awards and prizes to which I would otherwise be entitled. In the event of my resignation, whether voluntary or upon request of The Miss Rodeo Minnesota Association, I recognize the right of association to select my successor and such person so selected shall be entitled to receive such prizes and awards as may be determined by the association.

5. I agree that as “Junior Miss Rodeo Minnesota,” I will dress appropriately, in western attire, complete with clean crown and banner, to any and all appearances and functions representative of “Junior Miss Rodeo Minnesota” and be perfectly groomed at all times including the time I travel to and from such appearances and functions.
6. I agree to abide by the standards of conduct set forth in the 2023 Junior Miss Rodeo Minnesota Pageant rule book, as signed and agreed to upon my entrance into the pageant and the Junior Miss Rodeo Minnesota Handbook, which accompanies this contract.
7. I agree that this Contract shall solely and exclusively determine my rights and obligations relating to my duties and responsibilities during my term as “Junior Miss Rodeo Minnesota”. In the event of any occurrence or situation arising or any personal acts that I perform during my term as “Junior Miss Rodeo Minnesota” which are or are not specifically covered by this Contract which, in the opinion of the Directors of The Miss Rodeo Minnesota Association jeopardize or threaten the reputation of public standing of the title and office of “Junior Miss Rodeo Minnesota”, the Directors of The Miss Rodeo Minnesota Association may take whatever action they, in their sole discretion, deem appropriate, including the remedies hereinabove specified.
8. I understand that I shall be solely responsible for my personal property and physical well-being; and that I shall neither ask for, expect, nor receive compensation or reimbursement from The Miss Rodeo Minnesota Association., its Directors, Officers, employees or agents, for any injury or loss sustained by me as a result of participating in the activities as Junior Miss Rodeo Minnesota or any activity under this contract.
9. I agree to hold harmless the Miss Rodeo Minnesota Association; it’s Directors, Officers, employees, and agents from any and all liability for my actions and conduct during my term as “Junior Miss Rodeo Minnesota.”
10. I understand that I may not compete in any rodeo that I will be making an appearance as “Junior Miss Rodeo Minnesota” unless there is prior approval from the MRMNA.
11. I understand that Miss Rodeo Minnesota Association is in no way responsible for my traveling expenses to and from said appearances. Title winners must understand that if they win a title the funding for all expenses including travel and wardrobe will be their responsibility.
12. I agree that The Miss Rodeo Minnesota Association may (but shall not be required to) designate my chaperone and traveling companion while I am engaged in activities related to my participation in events as “Junior Miss Rodeo Minnesota”. I further agree that The

Miss Rodeo Minnesota Association shall approve my chaperone and traveling companion.

13. It is my understanding that I cannot be escorted to, from or during any official function as “Junior Miss Rodeo Minnesota” by anyone other than a chaperone designated by the National Director and/or a parent/guardian.
14. I understand that as “Junior Miss Rodeo Minnesota,” I may be required to travel to Professional Rodeo Cowboys Association (PRCA) events as determined by The Miss Rodeo Minnesota Association during my term as “Junior Miss Rodeo Minnesota.”
15. I understand that if I should receive the use of an automobile, pickup or trailer for my term as “Junior Miss Rodeo Minnesota” that I and/or my parents/guardians will solely be responsible for the insurance covering those vehicles for said term.
16. I also agree I will attend all functions and be present all days and nights during the following year’s Miss Rodeo Minnesota Pageant, Coronation of Miss Rodeo Minnesota, and at scheduled events as indicated by the Miss Rodeo Minnesota Association.
17. During my reign as “Junior Miss Rodeo Minnesota,” it is understood that I will reside in the State of Minnesota.
18. During my reign as “Junior Miss Rodeo Minnesota,” I understand that I cannot co-habitat with anyone of the opposite sex other than an immediate family member.
19. During my year as “Junior Miss Rodeo Minnesota” my social media pages should be placed in inactive status.
20. I also agree that during my year of reign, until the day I give up said title of “Junior Miss Rodeo Minnesota,” that I will not wear another crown or buckle with any other title or give any representation of any other title but that of “Junior Miss Rodeo Minnesota”, to do so would be breaking my contract with the Miss Rodeo Minnesota Association.
21. Junior Miss Rodeo Minnesota shall write thank you notes in a timely manner for the following reasons: items donated for auctions, horses donated, rooms donated, monetary donations, gifts, etc. Electronic thank you letters are not acceptable.
22. The MJrRMN crown is the Association’s possession to be used by MJrRMN during her year. During her reign, the queen is liable for, which includes but is not limited to, maintenance, damage, loss or theft of the crown. MJrRMN will agree to provide insurance in the amount of \$ 225 for the MJrRMN crown during her reign. Proof

of the MJrRMN crown insurance policy must be sent to the MJrRMN board. The buckle is a gift to MJrRMN and is hers to keep.

23. Sponsors solicited by Junior Miss Rodeo Minnesota are considered “association sponsors,” and must be approved by the MRMN Committee.
24. The use of the Miss Rodeo Minnesota logo is expressly controlled by the MRMN Committee and cannot be reproduced or used in ANY manner without the express permission of the MRMN Committee. The image and likeness of Junior Miss Rodeo Minnesota, including the title itself, is also expressly controlled by the MRMN Committee; therefore, any advertising, marketing or promotion of any product or service by Junior Miss Rodeo Minnesota must be approved in writing by the MRMN Committee.
25. Junior Miss Rodeo Minnesota shall work closely with the MRMN Committee, understanding that communication with the National Director is critical, and shall contact the National Director to clarify any and all questions regarding her duties and responsibilities. Junior Miss Rodeo Minnesota shall meet with the MRMN Committee no fewer than two times during her reign. Dates for these meetings will be provided by the MRMN Committee.
26. Junior Miss Rodeo Minnesota symbolizes the youth of the state of Minnesota. She is the ideal, western type American girl. Any behavior and/or activities performed by Junior Miss Rodeo Minnesota that would contradict this ideal image may result in the termination of her reign.
